

OFFICIAL RULES for Summer of Yeli Giveaway

Fox Communities Credit Union (“Fox”) (the “Promoter”) of Summer of Yeli Giveaway Official Rules (“the Promotion”) will award two (2) Grand Prizes, three (3) Second Prizes, five (5) Third Prizes, and eight (8) additional prizes through random drawings from among all eligible entrants.

By entering into any Fox promotion, the participant (“Participant”) agrees to abide by these Official Rules and the decisions of the Promoter, such decisions which are final and binding in all respects.

NO PURCHASE NECESSARY TO ENTER or WIN. ACQUIRING A FOX MEMBERSHIP, PRODUCT, OR SERVICE IS NOT REQUIRED TO ENTER AND WILL NOT INCREASE YOUR CHANCES OF WINNING. Participants may earn additional entries through various methods described in the official rules. SEE THE “AUTOMATIC ENTRY” AND “MANUAL ENTRY” SECTIONS FOR FURTHER INFORMATION. VOID WHERE PROHIBITED BY LAW.

Promotion Period: Summer of Yeli Giveaway begins on June 4th, 2026 at 12 a.m. Central Time (“CT”) and ends on August 28th, 2026 at 11:59 p.m. CT (the “Promotion Period”).

Eligibility: Giveaway’s are open solely to natural persons who are (1) legal U.S. residents who are at least 18 years of age or older at the start of the Promotion Entry Period, (2) a member of Fox or a non-member that meets Fox’s membership eligibility requirements, and (3) not otherwise ineligible under these rules. Team members, officers, members of the Board of Directors or agents of Fox (“Promoter”) and their immediate family members are not eligible to enter the promotion. Immediate family includes spouses, parents, siblings, children, in-laws, stepparents, stepchildren, grandparents and grandchildren. All applicable federal, state and local laws and regulations apply. Void where prohibited or restricted by law. Fox has the right to confirm eligibility before awarding a prize.

How to enter: There are two (2) methods of entry for Giveaway. You may enter by either Automatic Entry or Manual Entry as hereinafter described during the “Promotional Period.” METHOD OF ENTRY IS LIMITED TO ONE (1) MANUAL ENTRY PER PERSON. AUTOMATIC ENTRIES ARE LIMITED TO ONE (1) ENTRY PER PERSON FOR EACH ELIGIBLE NEW ACCOUNT OPENED OR SHARE CERTIFICATE RENEWED.

Automatic Entry: Each new or renewed eligible account opened during the Promotional Period (as defined herein) will automatically receive one (1) entry per new or renewed account opened into the Promotion. This automatic entry applies to both new and existing members of Fox.

For accounts with joint account holders or co-borrowers, only one (1) automatic entry will be issued in the name of the primary member. Joint account holders or co-borrowers may obtain an additional entry by participating in the Manual Entry process, subject to the terms and conditions set forth in these Official Rules.

Eligible accounts include: renewed share certificates; new checking, savings, and share certificate accounts; Fox credit cards; first mortgage purchase or construction loans; home equity loans and lines of credit; secured and unsecured direct consumer loans; and business or commercial loans to natural person borrowers.

Certain accounts may be excluded from automatic entry, including but not limited to KA-Pow savings accounts. However, individuals associated with excluded accounts may still be eligible to enter the Promotion through the Manual Entry process, provided all eligibility requirements are otherwise satisfied.

All accounts and loans are subject to Fox’s approval criteria, underwriting standards, and account opening requirements.

Manual Entry: An eligible person may enter the Promotion by visiting foxcu.org/landing/summer-of-yeli-entry and completing the online manual entry form. Limit one (1) total manual entry per person during the Promotion Period. Individuals who receive an automatic entry as described in these Official Rules are not eligible to submit a manual entry.

Promoter will not consider incorrect, fraudulent, incomplete, late, or otherwise non-conforming entries. Entries must be received during the Promotional Entry Period. Any entrant using fraudulent means to participate in the Promotion will be disqualified. All entries, once provided, are the Promoter's sole and exclusive property. No photocopy or mechanically reproduced entries accepted; the Promoter is not responsible for lost, misdirected or incomplete entries.

Prize Drawing: Weekly drawings for non-grand prize items will be conducted on or about the following dates: July 13, July 20, July 27, August 3, August 10, August 17, August 24, and August 31, 2026. Then on or about August 31, 2026, the Grand Prize, Second Prize, and Third Prize winners will be selected through a random drawing from all eligible entries received during the Promotion Period. The Promoter will randomly select one (1) potential winner for each applicable prize from all eligible entries received during the corresponding entry period. Potential winners will be notified by phone and/or email.

Entries selected as weekly winners will be re-entered into subsequent drawings and will remain eligible for the Grand Prize, Second Prize, and Third Prize drawings. Promoter is not responsible for digital communications that are undeliverable or any other failure beyond reasonable control. In the event of a dispute with respect to entries received from more than one user having the same e-mail address/account, the authorized subscriber of the account in question at the time of entry will be deemed the proper entrant. The winner need not be present to win. Odds of winning will depend upon the total number of eligible entries received.

Prize(s):

Grand Prize (2): Two (2) Grand Prizes each consisting of a signed Christian Yelich ("Yelich") jersey, along with the opportunity for the winner and one (1) guest to meet Yelich at a date, time, and location determined by the Promoter in its sole discretion. Each with an Approximate Value ("AV"): \$300.00.

Second Prize (3): Three (3) Yelich autographed wood bases, each with an AV of \$150.00; awarded one (1) per winner.

Third Prize (5): Five (5) Yelich autographed mini baseball bats, each with an AV of \$100.00; awarded one (1) per winner.

The Grand Prize, Second Prize, and Third Prize winners will be selected in a final drawing conducted on or about August 31, 2026.

Weekly (Non-Grand) Prizes (8): Eight (8) Yelich autographed baseballs, each with an AV of \$100.00; awarded one (1) per winner. Weekly (non-grand) prizes will be randomly selected and awarded in the weekly drawings described under "Prize Drawing" from all eligible entries received during the applicable entry periods, subject to verification of eligibility and compliance with these Official Rules.

All prize(s) are non-transferable, and no substitution will be made except as provided herein at the Promoter's sole discretion. The winner will pick up their prize from the nearest Fox location, within 30 days of prize drawing. Potential winner will forfeit his or her Prize if he or she (1) fails to respond in a timely fashion to Fox's request for information with respect to the giveaway; (2) cannot be reached at the information provided by such individual; (3)

fails to claim Prize in stated time frame; (4) rejects the Prize (or it is returned undeliverable through no fault of Promoter); or (5) is disqualified from the Giveaway for any reason. In the event of any forfeiture hereunder, an alternate winner will be selected.

Taxes: Prize winners are solely responsible for all applicable federal, state and local taxes. The winner may be required to complete a W-9 form and may receive an IRS form 1099-MISC reflecting the prize amount.

Additional Rules: By entering and/or participating in the Promotion, participants agree to indemnify and hold harmless Fox Communities Credit Union and their respective subsidiaries, affiliates, advertising/promotion agencies and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the "Promotion" or receipt or use or misuse of any prize.

By accepting the Prize, the winner consents, to use of his or her name, photograph, video, voice and/or likeness, for advertising, trade and/or publicity purposes without additional compensation in all media now known or hereafter discovered, worldwide web, and on the Internet and/or World Wide Web, without notice, review, or approval, except where prohibited by law.

Fox reserves the right to cancel, suspend and/or modify the "Promotion", if any fraud, technical failures, human error, or any other factor impairs the integrity or proper functioning of the "Promotion", or any event or cause beyond Fox's control (e.g. events such as natural calamities, national emergencies, wide spread illnesses, declarations of war, acts of God, act of terrorism") interferes with any aspect of the "Promotion", including but not limited to fulfillment of the prize, as determined by Fox in its sole discretion. In the event of cancellation, modification, or suspension, Fox reserves the right to select the winner in a random drawing from among all eligible entries received prior to the time of the event warranting such cancellation, modification, or suspension.
